ROSTAMI: Good, how are you doing? 10 Vahid Rostami from Atzl, Nasher and Zigler. 11 So Oak Ridge is, as you know, up for 12 It's a five-lot subdivision, and reapproval. 13 was in front of the Board, and received final 14 conditional approval last year, the exact was 15 February 22, 2024. Over the -- the plan was 16 never filed with the County within 120 days, 17 so the approval was lapsed. So here we are 18 with the same plans, same lot sizes, and the 19 design, same bulk tables. And there's a lot of statements 15 made in this email. But I think the gist of 16 it is that she doesn't support this 17 application. 18 MR. ROSTAMI: Well, we had discussion 19 with Ms. Mason as well. And I don't know 20 what date that was in. But after that, we 21 had a meeting and --2.2 MR. STACH: April 16th. 23 MR. ROSTAMI: Okay. So that's after 24 approval. Because after that, we sat down 25 and came to an agreement to provide a change,

19	written comments to this Board.
20	MR. QUEENAN: You had come to the TAC
21	meeting. You said you were going to
22	incorporate changes.
23	MR. ROSTAMI: Yeah. This was after our
24	meeting with Barbara Mason, that we sat down
25	and agreed on what changes were satisfactory.

2	MR. QUEENAN: So are those changes on	
3	the map?	
4	MR. ROSTAMI: Well, in terms of the	
5	driveway and what she wanted to basically	
6	support the application, yes. But I'm not	
7	aware of that letter of April 16th because	
8	that was after the TAC, right?	
9	MR. STACH: That was eight days ago.	
10	MR. QUEENAN: Yeah, but	
11	MR. ROSTAMI: Yeah.	
12	MR. QUEENAN: Fine. But you said these	
13	maps haven't changed since the prior	
14	approval.	
15	MR. ROSTAMI: Lot sizes and bulk	
16	requirement didn't change. So the only	
17	change in my view is actually this one, and	
18	making the adjustment to the driveway	
19	location for Lot 5.	
20	MR. QUEENAN: All right. And how did	
21	you, how did you change it?	
22	MR. ROSTAMI: We're going to use the	
23	existing drive for Lot 5 and just make it	
24	wider. So that's from, like, currently nine	
25	or ten feet, so going to expand it to	

6 1 Proceedings 2 18 feet. 3 MR. QUEENAN: Because this, the map you 4 submitted still shows the two --5 MR. ROSTAMI: Yeah, this was actually 6 the initial submission. But we're going to 7 correct it prior to signing the map. 8 Actually, next submission. 9 MR. OUEENAN: Yes. Thank you. And so I 10 think what the Board, and I think what Max is 11 getting to, and probably what Steve is going 12 to opine on is I think we're going to need in 13 writing from your co-applicant that she's in 14 agreement and supports whatever gets placed 15 on the map. 16 MR. ROSTAMI: Eventually we'll need her 17 support to --18 MR. QUEENAN: I think you need it sooner 19 rather than later. 20 CHAIRMAN JOHNSON: 21 BOARD MEMBER PURCELL: In writing. 22 CHAIRMAN JOHNSON: For everybody's sake. 23 BOARD MEMBER PURCELL: For our attorney 24 to review. 25 MR. HONAN: I think as long as her new

ROSTAMI: Yeah. My understanding 7 was that was actually, that would be the next submission and had the rest of that. So it 8 9 will include, yeah. 10 CHAIRMAN JOHNSON: So the next 11 submission will come with a letter from 12 Ms. Mason? 13 MR. OUEENAN: Yeah. So your next 14 submission should update the plan, whatever 15 changes and agreement you've made, along with 16 a letter from the co-applicant indicating 17 that she's in agreement. 18 MR. ROSTAMI: I'll make sure that we get 19 that. 20 MR. QUEENAN: So I would suggest 21 bringing that to the TAC meeting so that can 2.2 be verified before coming to the next. 23 BOARD MEMBER PURCELL: If you get it, 24 can you please send it to Steve and Mary. 25 She can get it to every, Mary can get it to
