Supervisor Sherwood opened the continued public hearing at 8:21 pm.

PUBLIC INPUT

<u>Susan Filgueras</u>, Mott Farm Rd, Tomkins Cove spoke regarding drainage issues in the town, and asked that the Town look at existing issues and protect those who are experiencing problems.

<u>Frank Collyer</u>, Knapp Rd indicated that he had spoke at length at the last meeting and is still attempting to put his concerns in writing. He asked that the public hearing be extended in order to give him time to do this.

Town of Haverstraw

The following letter was read:

On behalf of the Town of Haverstraw, we are requesting that the public hearing regarding reviewing the Stony Point Master Plan be left open so that the Town could have an adequate amount of time to review and respond to any impact it may have on your neighboring town. We respectfully request a 30-day extension in order for our Planning Consultant, Engineer and Council to complete their review. Howard T. Phillips, Jr. Supervisor

Robert Geneslaw, Town Planner, spoke indicating that once the public hearing is closed the Town Board needs to indicate which of the items in the proposed plan presented by the Commission are acceptable to the Board so that the environmental review can be started.

It was the general consensus of the Town Board to continue the public hearing to the June 28, 2011 meeting.

AGENDA ITEMS

<u>Supervisor Sherwood</u> indicated that three items were added to the agenda at the last minute as follows:

DONATION - NORTH ROCKLAND COMMUNITY DAY

A motion was made by Councilman Vicari, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of those board members present to approve a contribution of \$1,500 for the North Rockland Community Day on June 5th.

SEWER DEPT - SEMINAR

A motion was made by Councilman Vicari, seconded by Councilman White and **unanimously carried** by a voice vote of those board members present to approve our Sewer Department Chief Operator's attendance at the NY Water Environment Association's Seminar in Yonkers, NY at a total cost of \$50.00.

HOME RULE LEGISLATION

The following resolution was moved by Councilwoman Konopko, seconded by Councilman Vicari and **unanimously carried** by a role call vote of those board members present:

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF STONY POINT (THE "TOWN") ADOPTING A "HOME RULE" REQUEST WITH RESPECT TO THE ENACTMENT OF SPECIAL LEGISLATION BY THE NEW YORK STATE LEGISLATURE TO AMEND THE LOCAL FINANCE LAW SO AS TO AUTHORIZE AND EMPOWER THE TOWN TO AMORTIZE THE COSTS OF PAYMENTS TO OR FOR THE BENEFIT OF EMPLOYEES UPON SEPARATION OF SERVICE FROM THE TOWN.

WHEREAS, by resolution adopted on April 12, 2011, the Town Board (the "Town Board") of the Town of Stony Point (the "Town") authorized the submission of a request to the New York State Legislature of the enactment of special legislation to amend the New York State Local Finance Law Section 11.00 TO authorize and empower the Town to amortize the cost of the costs of payments to or for the benefit of employees upon separation of service from the Town; and

WHEREAS, there has been introduced into the State Senate as Bill No. S 5362 and into the Assembly as Bill No. A 7273, an amendment to the Local Finance Law that would add a new Subdivision 105 of paragraph A. of Section 11.00. to read as follows:

105. Payments by the town of Stony Point to or for the benefit of employees upon separation from employment, as may be approved by the town and including, but not limited to, cash payment for separation incentives and/or payment of the monetary value of accrued and accumulated but unused and unpaid sick leave, personal leave, holiday leave, vacation time, time allowances granted in lieu of overtime compensation, premiums or contributions with respect to health, dental and vision care insurance plans for the fiscal year in which such separation occurs, and any other forms of payment required to be paid to or for the benefit of such employees in connection with the separation from employment, ten years.

(the "Special Legislation");

WHEREAS, as a condition precedent to the approval of such Special Legislation by the State Senate and Assembly, the Town Board is required to adopt a Home Rule Request requesting the enactment thereof and declaring that a necessity exists for such enactment;

NOW, THEREFORE, IT IS RESOLVED BY THE TOWN BOARD OF THE TOWN AS FOLLOWS:

- 1. The submission of the request for enactment of the Special Legislation by the State Legislature is hereby approved and the Town Board hereby declares that a necessity exists for such enactment.
- 2. The Town Supervisor and the Town Clerk are each hereby authorized to complete the Home Rule Request, in the form presented to the Town Board and attached hereto as Exhibit A, evidencing the Town Board's request for enactment of the Special Legislation; and are hereby further authorized to certify to the approval of such Home Rule Request by the Town Board and to submit the same to the State Legislature on behalf of the Town.

BID - MOTOR CONTROL CENTER - SEWER DEPT

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of those board members present to authorize the Town Clerk to advertise for bids for a Motor Control Center for the sewer plant, subject to approval of the specifications by the sewer department and the town engineer.

BID-FILTRATION SYSTEM – MUNI POOL

A motion was made by Councilman Finn, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of those board members present to award the bid for replacement of the filtration system at the Bulsontown Road pool to All State Technology Inc. in the amount of \$124,000 upon correction of the several correctable deficiencies in the bid as advised by Special Counsel.

BID - ROAD RESURFACING

A motion was made by Councilman Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present to award the bid for roadway resurfacing to Tilcon New York, Inc, as follows:

USE OF FACILITIES - SENIOR CLUB II

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** to grant permission to the Stony Point Senior Citizens Club II to hold a fund raiser at the Community Center on June 30, 2011, including use of the kitchen facilities.

CONCESSION STAND AT POOL

A motion was made by Councilman Finn, seconded by Councilman White and **unanimously carried** by a voice vote of those board members present to grant approval to Gary Wyrachnaksy to run a concession stand at the pool for the 2011 season if he is still interested in doing so.

COLLECTION OF SCHOOL TAXES

<u>Councilman Vicari</u> challenged the notion that we can relinquish our right to collect school taxes and receive a fee for doing so, as indicated in a recent letter from the Superintendent of Schools.
