Chief Moore reported that telephone notification will go out to all residents regarding the time and route of the Wayne Day Parade on Saturday, July 16th.

OVERTIME REPORT

A motion was made by Councilman White, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to approve the overtime report for the month of June 2011 as presented.

• SICK LEAVE REPORT

A motion was made by Councilman Finn, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to approve the overtime report for the month of June 2011 as presented.

• UPDATE - BURGLARIES AND CAR LARCENIES

<u>Chief Moore</u> advised that there has been a sharp increase in car larcenies; 30 since June 25th. Most of the vehicles have been unlocked.

• INTELLIGENCE TASK FORCE ASSIGNMENT

Officer J. Wood has been promoted to sergeant, leaving a vacancy on the task force. One applicant has asked for a little more time.

• YOUTH OFFICER TRAINING

A motion was made by Councilman Finn, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to authorize our youth officer to attend the training session in Dallas, TX in August. All charges to be paid for through a grant received by the District Attorney's Office.

ECONOMIC DEVELOPMENT COMMITTEE REPORT

 <u>Councilwoman Konopko</u> reported that the RFEI Subcommittee met today for a second draft session and is requesting input from the building inspector. They would like to have a final draft for review by the next town board meeting.

LEGISLATIVE REPORTS

- <u>Senator Carlucci's Report</u> since the Senate is not in session, there was no report.
- <u>Legislator Jobson's Report</u> the Washburns Lane project is progressing well.

SUPERVISOR'S REPORT

We will hear about the pool from our town engineer but I do want to congratulate and thank him for his hard work. He designed and built a beautiful filter system that is up and running. This is a complex project and it is truly a magnificent filter system at far less cost than the proposals we received from outside contractors. We should have final numbers before the next meeting.

All of our departments have been helping out including parks, highway, recreation and sewers. They have been providing equipment and manpower to get the new system installed, wired and up and running and I want to thank them all for the effort. If the health department cooperates it is possible the pool will open this weekend or on Monday.

I have exciting news for our residents as well from Congresswoman Nan Hayworth. She will be coming to our town for a Town Hall style meeting that will be held right here in our community center. The Congresswoman has agreed to be here on August 9 before our town board meets that night to speak with and take questions from the public and tell us a little about what is going on in Washington.

Congresswoman Hayworth will be available at 5:30 p.m. on August 9 and has agreed to stay until our regular board meeting starts at 7 p.m. that evening. If you have questions for her mark your calendars and plan to be here. This may be the first time we have had the chance to meet one on one with our congressional representative in this type of setting right here in Stony Point.

In other good news our mortgage tax revenues, which have been lagging, got a shot in the arm from a substantial real estate transfer in the last quarter so we are now running a little ahead of last year in that revenue stream.

We will need to continue to push for additional ways to enhance our revenue stream because we face a very tight 2% property tax cap. With retirement and health insurance premiums increasing in the double digits and the town continuing to run on bare bones staffing it is going to be another very difficult budget year.

As always, and I know the board agrees with me on this, additional revenues are not about more taxes, they are about more taxpayers. Bringing ratable into the town is this board's top priority and while we continue to push for lower costs and more efficiency the only way to help our taxpayers is to bring more business into the town.

Finally we have the annual Wayne Day celebration starting this week as you can see from the rides and attractions on the way in to our community center. Great attractions and wonderful food and music and so it is a fun way to entertain your families at a very reasonable price and of course help support our volunteer heroes. So plan on bringing the family for a fun night out. The town will be having a table on local business night as we did last year so if you want to stop by and chat with me or any board members who may be present come on down on Friday night.

The annual firemen's parade will take place this Saturday at 2 pm and it will start at Washburn's Lane and continue to the firehouse on Liberty Drive with a reviewing stand near the Farley Bridge. Bring the family to the parade and show how much we appreciate the officers and men who devote so much volunteer time protecting our community.

Kevin Maher, Town Engineer gave a status report on pool repairs.

Discussion developed between Town Board and Town Engineer.

ACTION

A motion was made by Councilman White, seconded by Councilwoman Konopko and unanimously carried by a voice vote of those board members present to authorize an additional amount of up to \$15,000 over and above the amount previously authorized for pool improvements.

Phil Lima, Day Camp Director spoke indicating that parents are concerned that the children are not able to swim everyday, especially in the extreme temperatures we've been experiencing.

<u>DUNDERBERG ROAD</u> – Kevin Maher, Town Engineer advised the Town Board that to continue the work needed to rectify the drainage situation on Dunderberg Rd. it would cost an additional \$8,000 above the costs already incurred. No action was taken at this time.

ENFORCING SIGN ORDINANCE

<u>Councilman Vicari</u> indicated that he has been receiving complaints from people about the sign situation in town and asked if there was any interest on the board for looking into strengthening the code, especially the enforcement section.

ACTION

It was the general consensus of the Town Board that Councilman Vicari and Councilman Finn act as a subcommittee to look into this matter.

<u>LETTERS OF CREDIT – STONY RIDGE HOLDING (STONY RIDGE ESTATES)</u>

A motion was made by Councilman Finn, seconded by Councilman Vicari and unanimously carried by a voice vote to adopt the following resolution subject to the approval of Harold Y. MacCartney and to accept the deeds of dedication, subject to approval of Mr. MacCartney:

RESOLUTION STONY RIDGE HOLDING CO, INC STREET DEDICATION

WHEREAS, Stony Ridge Holding Co., LLC (the "Owner") has offered, and has requested that the Town accept for dedication, the following roadways serving the Stony Ridge Estates Realty Subdivision (the "Subdivision"), as shown on a map entitled "Stony Ridge Estates" filed in the Rockland County Clerk's Office on July 27, 2000 in Map Book 121 at Plat 10 as Map Number 7378 (the

"Filed Map"), and known as: (i) <u>Sandyfields Lane</u>; (ii) <u>Jobson Way</u> (as shown on the filed map as Johnsontown Road); (iii) <u>Lime Kiln Court</u>; (iv) <u>Antioch Court</u>; and (v) <u>Beaver Pond Court</u> (collectively the "Roads"); and

WHEREAS, the Owner has filed with, and the same are held by, the Town, the following four (4) separate Irrevocable Standby Letters of Credit ("LOC") to secure the completion of improvements for the Subdivision, each naming the Town as the named beneficiary thereof, and each issued by TD Bank, as successor to Hudson United Bank, as follows: (i) LOC No. 20000477 in the amount of \$37,900.00; (ii) LOC No. 20000478 in the amount of \$38,710.00; (iii) LOC no. 20000479 in the amount of 48,000.00; and (iv) LOC no. 20000480 in the amount of \$48,950.00; and

WHEREAS, we have received the statement from the Owner that all improvements for the Subdivision have been completed and installed in accordance with the Filed Map specifications and has submitted a copy of an As-Built Plan for the Subdivision prepared by Corless and Associates, last revised June 30, 2011 (the "Plans"), to the Board, and to the Town Engineer, the Town Superintendant of Highways and the Town Attorney; and

WHEREAS, the Town Engineer and Superintendent of Highways, upon inspection of the Roads and review of the Plans, have submitted their formal letters confirming the completion and installation of all Subdivision improvements in accordance with the Filed Map specifications and recommending acceptance of dedication of the Roads; and

WHEREAS, the deed for such conveyance, together with all documents required for the recording thereof will be reviewed by the attorney for the Town;

NOW THEREFORE be it;

RESOLVED, that the Town of Stony Point accept for dedication each of <u>Sandyfields Lane</u>, <u>Jobson Way</u> (as shown on the filed map as Johnsontown Road), <u>Lime Kiln Court</u>, <u>Antioch Court</u>; and <u>Beaver Pond Court</u>; and be it

FURTHER RESOLVED, that each of the following LOCs be surrendered and returned to the Owner, and are authorized to be cancelled by the Owner: (i) LOC No. 20000477 in the amount of \$37,900.00; (ii) LOC No. 20000478 in the amount of \$38,710.00; (iii) LOC no. 20000479 in the amount of 48,000.00; and (iv) LOC no. 20000480 in the amount of \$48,950.00; and be it

FURTHER RESOLVED, that upon delivery to the Town by the Owner of the executed deed, on a form approved by the attorney for the Town, the applicant shall record the conveyance of said improvement with the Rockland County Clerk.

LETTER OF CREDIT - BLANCHARD GATE

This matter was tabled to the July 26, 2011 Town Board meeting to allow time for the proposed resolution to be reviewed and approved by Counsel.

MASS GATHERING PERMIT-VIRGIN MARY & ST. PACHOMIUS CHURCH

A motion was made by Councilwoman Konopko, seconded by Councilman Finn and unanimously carried by a voice vote of those board members present to waive the public hearing for the purpose of a mass gathering and to issue the mass gathering permit to the Virgin Mary & St. Pachomius Church for their events on September 10-11 and 17-18, 2011,

MARRIAGE OFFICERS

A motion was made by Councilwoman Konopko, seconded by Councilman White and unanimously carried by a voice vote of those board members present to appoint Diane Payan, Court Clerk, and Barbara Oyer, Deputy Town Clerk as marriage officers.

HIRE COUNSELORS - DAY CAMP

At the request of Phil Lima, Day Camp Director, a motion was made by Councilman White, seconded by Councilman Finn and unanimously carried by a

voice vote of those board members present to hire Cathy Giordano (\$7.40/hr) and Chris Fondacaro (\$7.25/hr) as day camp counselors.

HIRE COUNSELORS - PLAYGROUND PROGRAM

At the request of Noreen Smith, Recreation Facility Supervisor, a motion was made by Councilman White, seconded by Councilwoman Konopko and unanimously carried by a voice vote of those board members present to hire Ryan Corcoran (\$7.40/hr), Jaimee Nigro (\$7.25/hr) and Timmy O'Brien (\$7.40/hr) as counselors for the playground program.

BID FOR ELECTRIC WORK – SEWER DEPARTMENT

<u>Councilman White</u> spoke regarding this matter. Specifications for this job have not been completed as yet. The work is needed in order to install a larger backup generator, necessary to qualify us for the energy saver program. He urged that this matter be taken care of as quickly as possible.

MASTER PLAN

Supervisor Sherwood recapped as follows:

- Recommendations have been received from the Master Plan Committee.
- Public Hearings have been held and recommendations received.
- Should planner go ahead with environmental reviews so that we are in a position to have a public hearing on a local law to adopt these recommendations.
 - Is there anything we need to eliminate from the environmental review because there is no chance that we will adopt it.

Conversation developed between Town Board members regarding various aspects of the recommendations from the Master Plan Committee, including Town Houses and Condos and Accessory Apartments. These are not zoning changes that are being considered; any zone changes would be acted on separately.

ACTION

A motion was made by Councilman White, seconded by Councilman Vicari and unanimously carried by a voice vote of those board members present to authorize the Town Planner to go ahead with the Environmental Quality Review forms for all of the suggestions.

EXECUTIVE SESSION

At 8:55 pm a motion was made by Councilwoman Konopko, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present to adjourn into executive session for the purpose of discussing personnel and litigation issues.

A motion was made by Councilman Finn, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to adjourn the July 12, 2011 Stony Point Town Board Meeting at 10:20 pm.
