#### RESOLUTION ADOPTING LOCAL LAW NO. 2 OF 2023 LOCAL LAW TO AMEND CHAPTER 194 (TAXATION) OF THE TOWN CODE REGARDING FIRST RESPONDERS

**WHEREAS**, the Town Board of the Town of Stony Point, New York ("Town Board") from time to time reviews its laws, rules and regulations to be certain the same are consistent with all current lawful practices as well as best practices to protect the health, safety and welfare of Town residents; and

**WHEREAS**, the Town Board desires to adopt a Local Law to Amend Chapter 194 (Taxation) of the Town Code; and

**WHEREAS**, upon notice duly published and posted, a Public Hearing was held on said Local Law on February 14, 2023 wherein public discussion was heard concerning the merits of said Local Law and after hearing from all those present wishing to speak and acknowledging that no written comments had been received, the Town Board declared the public hearing closed.

#### NOW, THEREFORE, BE IT RESOLVED by the Town Board as follows:

- <u>Section 1</u>. All "WHEREAS" paragraphs are incorporated herein by reference as though set forth in full.
- Section 2. The Town Board hereby adopts Local Law No. 2 entitled, "A LOCAL LAW TO AMEND CHAPTER 194 (TAXATION) OF THE TOWN CODE" providing a tax exemption for First Responders as attached hereto.
- Section 3. The Town Clerk is hereby directed to enter said Local Law into the minutes of this meeting and in the Local Law book of the Town of Stony Point, and to give due notice of the adoption of said Local Law by filing the Local Law in the Office of the Secretary of State in the State of New York.
- <u>Section 4</u>. This Resolution shall be effective immediately.

#### **TOWN OF STONY POINT**

#### LOCAL LAW NO. 2 OF 2023 AMENDING CHAPTER 194 (TAXATION) OF THE TOWN CODE OF THE TOWN OF STONY POINT, NEW YORK

A LOCAL LAW to amend Chapter 194, Article V, (Exemption for Members of Volunteer Fire Companies or Volunteer Ambulance Services) of the Town Code of the Town of Stony Point, Rockland County, New York pursuant to Section 466-a of the Real Property Tax Law of the State of New York.

BE IT ENACTED by the Town Board of the Town of Stony Point, Rockland County, New York ("Town Board") as follows:

#### Section 1. Purpose and Intent

The purpose of this Local Law is to amend Chapter 194 of the Town Code to authorize an exemption of up to 10% of the assessed valuation of the primary residence of volunteer firefighters and/or volunteer ambulance workers in accordance with Section 466-a of the New York State Real Property Tax Law. While the Town Code already provides for similar exemption, the Town must adopt a local law that conforms to the provisions of newly enacted Section 466-a of the New York State Real Property Tax Law in order to continue such an exemption.

#### Section 2. Authority

This Local Law is enacted pursuant to the provisions of 466-a of the Real Property Tax Law of the State of New York.

#### Section 3. Amendment

The schedule set forth in Chapter 194, Article V is hereby repealed, and replaced as follows:

#### § 194-20 **Statutory authority.**

The Real Property Tax Law has been amended by the addition of a new § 466-a which permits a Town to grant a partial tax exemption on real property owned by an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service or such enrolled member and spouse. Said partial exemption can be up to 10% of the assessed value of such property for all Town purposes.

#### § 194-21 Grant of exemption.

An exemption of 10% of assessed value of property owned by an enrolled member as set forth below, or such enrolled member and their spouse, is hereby granted from taxation with respect to the real property taxes of the Town of Stony Point so long as eligibility requirements as set forth below are met.

#### § 194-22 Eligibility.

A. Such exemption shall be granted to an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service provided that:

- (1) The property is owned by the volunteer firefighter or volunteer ambulance worker;
- (2) The property is the primary residence of the volunteer firefighter or volunteer ambulance worker;
- (3) The property is used exclusively for residential purposes;
- (4) The volunteer firefighter or volunteer ambulance worker resides in the Town of Stony Point and the Town of Stony Point is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance service;
- (5) The volunteer firefighter or volunteer ambulance worker is certified by the authority having jurisdiction as an enrolled member of such an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service: and
- (6) The volunteer firefighter or volunteer ambulance worker meets the minimum service requirement established by the Town of Stony Point, which is hereby established as two years.

#### § 194-23 Grants of lifetime exemption.

Any enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service and who is so certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, shall be granted the ten-percent exemption as authorized by this section for the remainder of his or her life as long as his or her primary residence is located within the Town.

#### § 194-24 Un-remarried spouse of enrolled member killed in line of duty.

The un-remarried surviving spouse of a deceased enrolled member killed in the line of duty, as certified by the authority having jurisdiction, is qualified to continue to receive an

exemption, as long as the deceased volunteer had been an enrolled member for at least five years and had been receiving the exemption at the time of his or her death.

#### § 194-25 Un-remarried spouse of deceased enrolled member.

The un-remarried surviving spouse of a deceased enrolled member, as certified by the authority having jurisdiction, is qualified to continue to receive an exemption, as long as the deceased volunteer had been an enrolled member for at least 20 years and the deceased volunteer and un-remarried spouse had been receiving the exemption at the time of his or her death.

#### § 194-26 **Application.**

A volunteer firefighter or volunteer ambulance worker must annually, or on before the applicable taxable status date, file an application for such property tax exemption with the assessor responsible for preparing the assessment roll for the Town of Stony Point, on a form as prescribed by the New York Commissioner of Taxation and Finance. The Town of Stony Point must maintain guidelines, available upon request, as to the requirements of an enrolled volunteer member relating to this exemption.

#### § 194-27 **Certification**.

The Town of Stony Point must annually file with the assessor, prior to the applicable taxable status date, a list of the active volunteer members who are certified to meet the minimum service requirement. Such list must provide, as of the applicable taxable status date, the number of years of service served by each such enrolled member and such enrolled member's address of residence.

#### § 194-28 No diminution of benefits.

An applicant who is receiving any benefit pursuant to Article 4 of the Real Property Tax Law as of the effective date of this article shall not have any of those benefits diminished because of this article.

#### Section 4. Repeal, Amendment, and Supersession of Other Laws

All other Resolutions, Ordinances or Local Laws of the Town of Stony Point, which conflict with the provisions of this Local Law are hereby superseded or repealed to the extent necessary to give this Local Law full force and effect.

#### Section 5. State Environmental Quality Review Act

Pursuant to 6 NYCRR 617.5 (20) and (27), this Local Law is classified as a Type II action which requires no further review under the State Environmental Quality Review Act.

#### Section 6. Severability

If the provisions of any article, section, subsection, paragraph, subdivision or clause of this Local Law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this Local Law.

#### Section 7. Code Preparation

The Town's Code preparation contractor is authorized, without further action of the Town Board, to correct typographical errors, numbering and other related technical changes that do not affect or alter the substantive provisions of this local law.

#### Section 8. Effective Date

This Local Law shall take effect immediately upon filing in the office of the

Secretary of State in accordance with Section 27 of the New York Municipal Home Rule Law.

# TOWN OF STONY POINT LOCAL LAW NO. 3 OF 2023 A LOCAL LAW OPTING OUT OF REAL PROPERTY TAX EXEMPTION FOR CERTAIN ENERGY SYSTEMS

BE IT ENACTED by the Town Board of the Town of Stony Point, Rockland County, New York ("Town Board") as follows:

#### Section 1. Legislative Intent.

It is the intent of this Local Law to remove the exemption from Town taxation contained in New York State Real Property Tax Law (RPTL) § 487 for, *inter alia*, any solar or wind energy system. RPTL § 487 grants a fifteen-year exemption from real property taxation on the increase in assessed value attributable to the construction of said systems. As such, and because the Town is substantially residential, the Town Board seeks to protect the Town's tax base by the adoption of this local law.

#### Section 2. Authority.

This Local Law is adopted pursuant to RPTL § 487(8)(a) which provides that a county, city, town or village may, by local law, provide that no exemption under this section shall be applicable within its jurisdiction.

#### Section 3. Removal of Exemption

Pursuant to this Local Law, the exemption provided by RPTL § 487 is hereby removed for the purposes of Town taxation and no such exemption shall be granted with respect to any solar or wind energy system, farm waste energy system, microhydroelectric energy system, fuel electric energy storage equipment and electric energy storage system, or fuel-flexible linear generator electric generating system, which began

construction subsequent to the date of legislative effect (January 1, 1991) or the effective date of such local law, whichever is later. Further, the Town opts out of this exemption for any other type of energy system that may be incorporated in RPTL § 487, unless a local law to the contrary is adopted.

#### **Section 4.** State Environmental Quality Review Act.

Pursuant to 6 NYCRR 617.5 (26) and (33), this Local Law is classified as a Type II action which requires no further review under the State Environmental Quality Review Act.

#### Section 5. Severability.

If a court of competent jurisdiction determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### **Section 6.** Code Preparation.

The Town's Code preparation contractor is authorized, without further action of the Town Board, to correct typographical errors, numbering and other related technical changes that do not affect or alter the substantive provisions of this local law.

#### Section 7. Effective date.

This Local Law shall be effective immediately upon filing with the Commissioner of the New York State Department of Taxation and Finance, the President of the New York State Energy Research and Development Authority, and the Secretary of State as may be necessary.
