SUBJECT: What are the Consequences to the Champlain Hudson Power

Express to the towns of Stony Point, Haverstraw and Clarkstown and how will

they impact, school taxes and the County?

I am told that the best way to solve a problem is to come with a solution.

SOLUTION: I am asking the County Executive to get involved with, the North Rockland School Superintendant, Supervisor's of the Towns of Stony Point and Haverstraw (SUPERVISORS call and ask the County Executive to get involved- we need his help) to develop a letter to the Governor stating the Champlain Hudson Power Express is not good for our community there was no Environmental Impact study done for the land installation in Rockland County.

CHPE undermines the economy,

- 1- there will be few if any jobs associated with CHPE in the Hudson Valley (FEIS and the Joint Proposal),
- 2- an isolated trajectory in a new path that does not connect to any existing NYS infrastructure,
- 3- Will it devalues the Bowline and Lovett sites further,
- 4- compromises the financial values of our homes by crossing over our properties
- 5- the installation route posses a great danger to our communities in conjunction with the CSX "Bomb Trains" carrying Bakken Crude and Tar Sands Oil, hundreds of millions of gallons right next to a 1,000 megawatt's of HOT electric transmission line, which will lay on top of 3 HIGH PRESSURE NATURAL GAS LINES, 21, 24, 36 that cross the Hudson River in the RAMAPO Fault in front of Indian Point.

Get started with a letter writing, post card campaign- an online petition- put the links on the Town web sites for easy access. I believe that if this project is built, the very fabric of our Towns will change and the Hudson River front through Rockland County will become the LOVE CANAL of the 21st century.

Attached and below is the letter I read at the North Rockland School Board meeting on October 7, 2014.

This e-mail is to prevent our being told by our elected officials – "I did not know this would happen or they told me that this would not happen".

The question I want answered is:

"In order to build the Champlain Hudson Power Express, Eminent Domain must be used. The property that CHPE crosses will be significantly devalued, I believe it is safe to say that the owners of the homes that the 1,000 megawatt electric transmission crosses will lose at least 10% of their marketable value I am not sure what percentage the Commercial properties lose, as well as their right to develop their property, so 10%.? What is the impact on the Stony Point Battlefield, will people want to visit it knowing that they are walking on 1,000 megawatts of HOT electric line, how safe is it!

SCHOOL TAXES

There is no doubt that the Champlain Hudson Power Express trajectory will devalue our homes, the question is how much? What are the Tax implications to the North Rockland School District residents. Especially since our properties will now be significantly devalued. How will we pay our taxes? Would you buy a home with a 1,000 megawatts of HOT electric running through your back yard 50 ft from your back door? See attached maps and below for the web-site.

The Champlain Hudson Power Express appears to have gotten its Presidential Permit. What are the consequences to NRCSD and how will it affect the Bowline and Lovett Power Plant site assessments?

What is on the table – Since the CHPE line will cross right in front of the Lovett property and the back of the Bowline Power Plant, remember that one of the initial arguments in the Tax Certiorari was that the plants were devalued due to Deregulation.

Will NRG have the ability to negate the agreement they made with the Town of Haverstraw and the NRCSD in 2014 by claiming that the properties now have no value as the Champlain Hudson Power Express has negated their ability to competitively compete in the electric market.

Our homes have already been devalued by the CSX \$26 million expansion that was announced to bring Bakken Crude and Tar Sands Oil to Albany. CHPE announced that they will install their 1,000 megawatt HOT transmission line within the CSX right of way. CSX's right of way is 25 ft off the center line of the outside rail, in many places there is no ROW; Eminent Domain will be liberally applied.

CHPE claims that the tax calculation is equal to that of CSX Railroad; the ROW of property that they are looking to steal from North Rockland is about 100 ft to each side of CSX starting at the North side of the Stony Point lighthouse going 8.2 miles through North Rockland.

CHPE's tax dollar calculation states that their payments to the Towns of Clarkstown, Haverstraw and Stony Point and Clarkstown North & South School Districts, and North Rockland School Dist-are approximately \$720,000 total or \$120,000 per entity. Far less than what they have paid to other upstate Towns.

Stony Point has approximately \$620,000 in Residential property values that will be affected and another \$500,000 in commercial property. Total potential in lost ratables is \$1,120,000 mil and if we lose 10% of those ratables which is a weak estimate of loss that is \$120,000 – that the taxpayer has to make up forget the additional assessments necessary to pay NRG.

I am not sure of Haverstraw dollars, but I can tell you the 1,000 megawatt "HOT" transmission line runs along side of the CSX Railroad tracks, so behind Benson Street, the Village Fairground II Town House development continuing on in the back of the homes on Hudson Ave.

How does this affect the agreement that Haverstraw and NRCSD made with NRG.

In early 2014, Haverstraw and the NRSD reached an agreement with NRG. In exchange for relinquishing any claims to over-assessments for the next seven years, NRG would receive an additional \$8 million total refund. As before, the school district bore the brunt, shouldering about half of the amount. The Town of Haverstraw was responsible for another third, with the remainder divided among the other taxing jurisdictions including the county and the Village of West Haverstraw. Additionally, NRG agreed to a Payment in Lieu of Taxes (PILOT) agreement of \$2.7 million a year, to be divided proportionately among the parties, for the seven years.

From a high of \$60 million a year in 1999, the total tax revenue generated by the large power plants of North Rockland dropped to barely \$3 million in 2014. Worse, North Rockland's Generating capacity was negated by NRG when the Lovett was demolished, and Bowline is severely underutilized by choice. However, NRG did report a \$200 million increase in profits recently.

REAL PROPERTY CHARGEBACKS

A motion was made by Councilman White, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all members present to approve the following resolution:

RESOLUTION ORDERING ASSESSMENT OF EXPENSES AGAINST LAND PURSUANT TO CHAPTER 78 OF THE TOWN CODE OF THE TOWN OF STONY POINT – 41 BEACH ROAD

WHEREAS, the Town Board, after compliance with notification requirements of the Town Code and after a public hearing commenced on May 13, 2014 and continued on May 27, 2014, June 10, 2014, June 17, 2014 and June 24, 2014, passed a Resolution, authorizing Town officials to take any and all necessary steps to repair, remove an otherwise secure ("the services") certain structures on parcels identified in Exhibit "A" annexed to this Resolution; and

WHEREAS, the Town caused such services to be performed consistent with the findings and recommendations of the Town's Building Inspector and in doing so performed the work and incurred the expenses set forth in Exhibit "A" for property located at 41 Beach Road in the Town of Stony Point as specifically set forth in Exhibit "A"; and

WHEREAS, Chapter 78 of the Town Code of the Town of Stony Point provides that All expenses incurred by the Town in connection with the proceedings to repair and secure or demolish and remove an unsafe building and/or abate the public nuisance, including the cost of actually removing such building and legal expenses, shall be assessed against the land on which such building is located and further provides that the expense so assessed shall constitute a lien and charge on the real property against which it is levied until paid or otherwise satisfied or discharged and further provides that such assessment shall be collected in the same manner and at the same time as other town charges, and that the same shall be placed on the tax assessment roll and levied against the property

NOW THEREFORE, BE IT RESOLVED as follows:

- 1. The above WHEREAS clauses are incorporated herein by reference.
- 2. The Town Board of the Town of Stony Point, after due deliberation, hereby:
 - a. Determines that the costs and expenses set forth in Exhibit "A" shall constitute a lien and charge on the real properties identified in Exhibit "A."
 - b. Authorizes the Town Assessor, Building Inspector, Finance Director, Town Clerk and any other Town Official whose assistance is required to carry out the provisions of this Resolution, to cause the costs and expenses set forth in Exhibit "A" to be assessed against the lands identified in **Exhibit "A"** and to collect such assessment in the same manner as other Town charges and, if not satisfied, to place same on the tax assessment roll and levy same against the subject parcels.
- 3. This Resolution shall take effect immediately.

GREEN ENERGY FACILITY RESOLUTION

<u>Stephen Mandracchia</u>, Esq. addressed the Board on behalf of his client MBC Holding LLC. and <u>Joseph McKay</u>, Esq, Special Counsel for the Town also spoke indicating that the prior resolution adopted by the Board on 9-23-14 should be rescinded and the entire matter should be referred to the Planning Board as this would make the process more efficient. After discussion the following action occurred:

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all members present to approve the following resolution:

RESOLUTION OF THE TOWN OF STONY POINT TOWN BOARD IN CONNECTION WITH THE PROPOSED WASTE TO BIO-FUEL FACILTY TO BE LOCATED AT THE END OF HOLT DRIVE

- **WHEREAS**, MBC Holding, LLC ("MBC") and Patrick Magee ("Magee") are proposing a waste to bio-fuel facility (the "Facility") to be located at 30/45/50 Holt Drive in the Town of Stony Point consisting of Tax Lot(s) Section 20.04, Block 11, Lot 03, and Section 20.02, Block 11, Lots 25 and 28 (the "Property"); and
- **WHEREAS**, the proposed Facility consist of over 400,000 square feet of building space spread out among ten buildings on approximately 44 acres of land. The Facility also includes bio-fuel production areas and product storage areas; and
- WHEREAS, On October 2, 2014, Town of Stony Point received a Petition from MBC and Magee for a zoning text amendment to allow the proposed Facility in the Town of Stony Point (the "Text Amendment Request"); and
- **WHEREAS**, the Town Board previously retained the law firm of Catania, Mahon Milligram & Rider, PLLC to serve as special counsel with respect to representing the Zoning Board of Appeals (ZBA) in connection with an appeal of the building inspector's interpretation regarding a proposed green industrial facility and subsequent Article 78 proceeding instituted by the Town of Haverstraw; and
- **WHEREAS**, on September 17, 2014, the Planning Board received a site plan application and concept plans for the proposed Facility (the "Site Plan Application") by MBC and Magee; and
- WHEREAS, on or about September 8, 2014, the Town received a Petition from MBC Holding, LLC to change the zoning designation of lot 28 from R-1 (Low Density Residential) to LI-2 (Light Industrial)(the "Map Amendment Request"); and
- **WHEREAS,** the Map Amendment Request, Text Amendment Request and Site Plan Application are collectively referred to as the "Applications"; and
- WHEREAS, prior to the receipt of the Site Plan Application and Text Amendment Request, on September 23, 2014 the Town Board declared its intent to be lead agency under the New York State Environmental Quality Review Act ("SEQR") with respect to the Map Amendment Request and circulated notice of its intent to other involved agencies; and
- **WHEREAS**, in light of the recent filings of the Text Amendment Request and Site Plan Application as well as the relationship between all three Applications, the Town Board would like to revoke its intent to serve as lead agency for the Map Amendment Request; and
- **WHEREAS**, section 215-130 of the Town's Zoning Code requires all petitions for zoning amendments to be referred to the Planning Board; and
- **WHEREAS,** section A221-2.F(1) Of the Town's Code requires all consultants working for the Town in connection with any land use applications, such as this one, to be authorized by the Town Board; and

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:

 The Town Board hereby revokes its intent to serve as lead agency with respect to the Map Amendment Request and authorizes the circulation of notice of the same; and

- 2. The Town Board directs the Town Clerk to refer the Text Amendment Request and re-refer the Map Amendment Request to the Town's Planning Board, as well as the appropriate County agencies; and
- 3. The Town Board authorizes the firm of Catania, Mahon, Milligram & Rider, PLLC to receive payment from the escrow accounts established for the Applications in connection with any necessary land use approvals and associated SEQR review related to the proposed Facility.

CORNELL COOPERATIVE EXTENSION LEASE

Renewal of this lease was discussed but **no action** was taken at this time.

DISCUSS MS4 ANNUAL REPORT 2014

<u>Kevin Maher Town Engineer</u> discussed the MS4 Annual Report for 2014 indicating that no real changes have taken place and that all appropriate agencies have been notified. **No action** was necessary of this matter.

DISASTER RECOVERY SUB RECIPIENT AGREEMENT

DISCUSS PROCUREMENT POLICY

BUDGET REVIEW

WHEREAS, a certain Town Employee has requested Extended Sick Leave pursuant to Article V, section 3 (F) of the Collective Bargaining Agreement between the Town of Stony Point and CSEA, Local 1000 AFSCME, AFL-CIO.

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby determines that such employee suffers from an illness requiring a prolonged absence and that such employee has utilized all of his accumulated sick and other leave credits, and therefore, conditioned upon such facts, the Town Board hereby grants Extended Sick Leave to such employee up to a maximum of six (6) months.
