STONY POINT TOWN BOARD MEETING - MARCH 24, 2015

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, March 24, 2015 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Geoffrey Finn called the meeting to order and led the group in the Pledge of Allegiance. Town Clerk Joan Skinner called the following roll:

PUBLIC INPUT

Mike Ehlers – Jenkins Ave. spoke:

- Speaking as a concerned Stony Point resident even though he is
 - Leading advocate of Stony Point Skate Park
 - o Member of Stony Point Skate Park Committee
 - Advisory board member of Stony Point PAL
- Overwhelming community support for Stony Point Skate Park
- Many have reached out to Senator Larkin inquiring if Stony Point will receive the same assistance (\$100,000) that Nyack and Newburgh have

Mr. Ehlers read the following email from Senator William J. Larkin:

"Thank you for your email on behalf of a skate park in Stony Point. I agree with you that this proposal would be a wonderful addition to the community and a great outlet for the children in the area. I wanted to let you know that in 2014 I awarded Stony Point a grant in the amount of \$75,000 to assist with the construction of both a dog park and a skate park. The skate park will be adjacent to the Vincent Clark Park. I believe both of these amenities will be wonderful additions to Stony Point and I look forward to their completion.

Thank you again for your email. If I can ever be of assistance to you, please do not hesitate to contact me."

- Was never aware of this
- Spoke with Councilman Basile
 - o Dog park has not received any assistance from the state
- Questions remain
 - When in 2014 did this happen
 - When was it announced
 - How will these items be split
 - Senator's email seems to indicate that it will be split equally with the dog park and the skate park
- An online article appearing on Saturday morning in the Rockland County Times indicated that none of the \$75,00 Dormitory Authority Grant will go to the Stony Point Skate Park
- Other questions
 - Why doesn't the Stony Point Skate Park qualify for the grant
 - How far along is the dog park
 - Why does the dog park qualify
- We should be certain that everyone is getting what the Senator intended them to get.

Councilman Monaghan spoke:

- o March 11, 2014 a unanimous resolution was passed by the Town Board to form a Dog Park Advisory Committee
 - o 5 town residents volunteered their time
 - o Councilman Basile and Councilman Monaghan are also members

Committee

- Visited possible locations within the town
- Spoke to residents
- Visited other dog parks
- o Formed a non-profit foundation in an effort to get donations to build a park at the lowest possible cost
- o Attempting to obtain donations for benches and water stations
- Councilman Basile was told by Senator Larkin that there may be a grant available through the Dormitory Authority
- No monies have been received
- Dog park would need to expend the money and then be reimbursed
- o Town Board does not decide on who receives the grants or how much is received
 - Should be speaking with the Dormitory Authority and Senator Larkin's Office

Supervisor Finn read the following excerpt from a letter dated 12/4/14 from the Dormitory Authority State of New York:

"Re: State and Municipal Facilities Program ("SAM") Construction of a Skate Park and Dog Park – Project ID: #6425

Dear Mr. Finn:

As you know, the Town of Stony Point has been approved by the State to receive a State and Municipal Facilities Program ("SAM") grant for the above referenced project in the amount of \$75,000 (the "Grant"). DASNY will be administering this Grant."

- There is a difference between being approved, being awarded and receiving a check
- Senator Larkin's recent email indicated "awarded"
 The Town Board does not make the decision of who gets what or how much they might get – this is done solely by the state, in this case DASNY.
- The usual process would be that the town would need to expend the money and then be reimbursed through the grant
- The town has asked someone from Senator Larkin's office to come and explain the situation

Prior to any grants being sought, the town budgeted \$15,000 toward the construction phase of the dog park

REALLOCATION OF FUNDS

The following resolution was duly offered by Supervisor Finn, and seconded by Councilman Javenes, to wit:

RESOLUTION 2015/22 REALLOCATION OF FUNDS STONY POINT DOG PARK/SKATE PARK

RESOLVED that:

1. \$15,000 that was allocated to the proposed Stony Point Dog Park pursuant to Section

- 2.III of a Resolution dated January 28, 2014 is hereby reallocated from such proposed Stony Point Dog Park to the proposed Stony Point Skate Park project to be located at 35 Beach Rd (SBL- 20.08-1-19) in the Town of Stony Point.
- 2. The Town Finance Director is hereby directed to take any and all actions necessary to carry out the provisions of this Resolution.
- 3. This Resolution shall take effect immediately.

The following roll call vote was recorded and the motion was unanimously carried:

APPROVE SALE OF 2006 CROWN VIC FROM POLICE DEPT. TO PARKS DEPT.

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the request of the Police Chief to sell a 2006 Crown Vic from Police Department to Buildings and Grounds Department for a fee of \$3500. The monies from Buildings and Grounds budget are to be transferred to the Police Account – Sale of Equipment Restricted - to pay for the installation and purchase of emergency equipment for the 2015 police vehicles.

REQUEST OF BUILDINGS' & GROUNDS - SURPLUS VEHICLES

A motion was made by Councilman White, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the request of the Buildings and Grounds Supervisor to surplus the following vehicles:

RE-HIRE SUMMER HELP – PARKS DEPT.

A motion was made by Councilman Javenes, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to re-hire the following summer help for the Buildings and Grounds Department:

Chris Cass - \$8.75/hr., Ken Ryder - \$8.75/hr., Jack Turbush - \$8.75/hr., Jeff O'Dell - \$15.38/hr. (pool operator)

<u>APPROVE - PURCHASE VEHICLE LIFT</u>

A motion was made by Councilman Javenes, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the purchase of a Mohawk TP-16,000 lb. two post vehicle lift at a budgeted price of \$16,350.80.

APPROVE - PURCHASE OF TIRE CHANGER

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the purchase of a Mohawk TCX575W Tire Changer, at a budgeted price of \$12,263.06

APPROVE - 2015 HIGHWAY SCHOOL

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the request of the Highway Superintendent to attend 2015 Highway School in Ithaca NY on June 1-3, 2015 at a price to the town of \$110.00 for early registration and the cost of hotel and travel expenses.

<u>APPROVE MONIES - BUILDING & FACILITIES IMPROVEMENT FUND - POLICE STATION</u>

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve monies (\$3,755.00) to be taken out of Building & Facilities Improvement Fund for a new heat exchanger for the 10 ton HVAC rooftop unit at the Police Station. Monies cannot be withdrawn from this fund until 30 days after April 2, 2015 as this motion is subject to permissive referendum.

<u>APPROVE MONIES – BUILDING & FACILITIES IMPROVEMENT FUND – VETERANS PARK</u>

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve monies (\$6,500) to be taken out of Building & Facilities Improvement Fund for additional work for the installation of the new hot box with heater around the existing 6" waterline and meter at Veterans Park. Monies cannot be withdrawn from this fund until 30 days after April 2, 2015 as this motion is subject to permissive referendum.

REQUEST - NRHS ACADEMY OF FINANCE

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the NRHS Academy of Finance request for a Summer Internship Position for six weeks at 20 hours a week at \$8.75 per hour.

LANDSCAPE MAINTENANCE FOR PATRIOT HILLS CLUBHOUSE

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the lowest quote (of four quotes solicited) received by the Director of Golf for the landscape maintenance at Patriot Hills Clubhouse, which was Ferguson Landscape & Construction, at a total of \$14,480.00 for two (2) years.

DISCUSS AUGUST/DECEMBER MEETING DATES

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to authorize one meeting to be held in the month of August, August 11, 2015, and one meeting in December, December 8, 2015.

REQUEST - TOWN CLERK'S CONFERENCE

A motion was made by Councilman White, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to approve the request of the Town Clerk to attend NYS Town Clerks Association 2015 conference in Rochester, NY. The cost will be approximately \$1200 for Conference registration, hotel, meals and travel.

EXECUTIVE SESSION

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present (Councilman Basile was absent) to adjourn into executive session at 7:47 pm to discuss personnel matters. Supervisor Finn announced that no further votes would be taken.

ADJOURN The March 24, 2015 Stony Point Town Board meeting adjourned at 8:15 pm and no further votes were taken.
