In the matter of the Petition of **Deaganne Daniel Veras** owner of more than one-half of the assessed valuation of all the taxable real property in the proposed Extension of Sanitary Sewer District **#2** in the Town of Stony Point, County of Rockland and State of New York and according to the latest completed assessment roll of the said town.

WHEREAS, a written petition dated: **October 19, 2022** has been presented to and filed with the Town Board of the Town of Stony Point praying that all the land situate in the Town of Stony Point, County of Rockland and which proposed extension, to be known as: Sewer Extension **2022/2** more fully described in the Schedule **"A", 15.20.4-41** annexed hereto, and

WHEREAS, the maximum amount proposed to be expended for the Extension of said district shall not exceed the sum of \$0.00 DOLLARS (\$0.00), and

WHEREAS, the expense occasioned by the creation of the Extension of Sanitary Sewer District #2 shall be assessed, levied and collected from the several lots and parcel of land within the said district in proportion as nearly may be to the benefit which each lot or parcel of land in said district will derive therefrom.

ORDERED that a meeting of the Town Board of the Town of Stony Point be held at Rho Building, 5 Clubhouse Lane in the Town of Stony Point on the November 9, 2022 at 7:00 PM to consider the said petition and to hear all persons interested in the subject thereof concerning the same, and for such other action on the part of the Town Board with relation to such petition as may be required by law, and it is

FURTHER ORDERED that the Town Clerk give notice of such hearing by publishing in the Town's Official Newspaper, a certified copy of this order and by the applicant posting certified copies of this order in five (5) places within said proposed Extension of Sanitary Sewer District #2 in the Town of Stony Point not less than ten nor more than twenty days before such hearing.

A motion was made by Supervisor Monaghan, seconded by Councilman Williams and unanimously carried by a voice vote of those board members present, with Councilman Rose being absent to set a Public Hearing to consider an amendment to the existing conservation easement with Tolake corporation to include one additional parcel within such conservation easement:

RESOLUTION AUTHORIZING THE SETTING OF A PUBLIC HEARING TO CONSIDER AN AMENDMENT TO AN EXISTING CONSERVATION EASEMENT WITH TOLAKE CORPORATION TO INCLUDE ONE ADDITIONAL PARCEL WITHIN SUCH CONSERVATION EASEMENT

WHEREAS, Grantor and Town are parties to a certain Agreement dated and effective as of March 1, 1999, in which the Town acquired from the Grantor a Conservation Easement on several parcels of undeveloped land located within a private residential community, known as the

Tomkins Lake Community ("TLC"), located within the Town of Stony Point, New York and owned by Grantor; and

WHEREAS, the Conservation Easement limits or restricts development of the land subject to the Agreement; and

WHEREAS, the Agreement dated March 1, 1999 had an expiration date of March 1, 2014; and

WHEREAS, by First Amendment to Conservation Easement Agreement dated December 30, 2010, the parties extended the term of the Agreement through March 1, 2025; and

WHEREAS, by Second Amendment to Conservation Easement dated September 10, 2018, the parties agreed to include five (5) additional undeveloped parcels of land located within TLC, as well as to extend the expiration of the Agreement through March 1, 2030; and

WHEREAS, Grantor is the owner of one (1) additional undeveloped parcel of land located within TLC: 7 Hillside Drive (s/b/1: 10.01-1-41) ("Additional Parcel"); and

WHEREAS, on October 22, 2022, the Tolake Corporation submitted a request to amend an existing Conservation Easement between the Town of Stony Point and Tolake Corporation ("Third Amendment to the Conservation Easement") to add the Additional Parcel; and

WHEREAS, the parties are desirous of amending the Conservation Easement Agreement to include the Additional Parcel; and

WHEREAS, including the Additional Parcel of undeveloped real property, the objectives that were outlined by the Town Board when it adopted the "Conservation Law

of the Town of Stony Point," Chapter 80 of the Code of the Town of Stony Point, specifically to preserve the scenic, open, and natural values of lands located within the Town, will be furthered by approving the Third Amendment to the Conservation Easement; and

WHEREAS, pursuant to Chapter 80 of the Town Code of the Town of Stony Point, consideration of such request requires the setting of a Public Hearing and referral of such matter to the Rockland County Planning Department and notification to adjacent property owners and the local School District.

NOW, THEREFORE, BE IT RESOLVED, that:

- <u>Section 1</u>. The above "WHEREAS" paragraphs above are incorporated herein by reference as if set forth fully.
- <u>Section 2</u>. The Town Board hereby authorizes the setting of a Public Hearing for November 22, 2022 at 7:00 p.m. to consider the request of the Tolake Corporation.
- Section 3. The Town Clerk is hereby directed and authorized to cause notice of such Public Hearing, pursuant to Town Code § 80-6(C) to be published in the Town's Official newspaper at least ten (10) days prior to November 22, 2022 and to cause written notice to be sent to any adjacent property owners, to the Rockland County Planning Department and to the North Rockland Central School District.
- Section 4. This Resolution shall be effective immediately.

Resolution to Set Public Hearing for Senior and Disabled Exemption
