RESOLUTION AUTHORIZING THE TOWN SUPERVISOR TO EXECUTE THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE TOWN AND CSEA, LOCAL 1000 AFSCME

WHEREAS, the Town of Stony Point and CSEA Local 1000 AFSCME ("CSEA") had previously entered a Collective Bargaining Agreement that expired on December 31, 2024; and

WHEREAS, the parties entered into negotiations in 2025, to negotiate terms of a new Collective Bargaining Agreement which terms were recorded in an executed Memorandum of Agreement for the period of January 1, 2025 through December 31, 2027; and

WHEREAS, the Town and CSEA have incorporated the terms of the Memorandum of Agreement into a revised Collective Bargaining Agreement; and

WHEREAS, the Town Board desires to authorize the Supervisor to execute the full Collective Bargaining Agreement on behalf of the Town in a final form approved by the Town's legal counsel.

NOW, THEREFORE BE IT RESOLVED by the Town Board as follows:

- <u>Section 1</u>. All "WHEREAS" paragraphs are incorporated herein by reference as though set forth in full herein.
- Section 2. The Town Board hereby approves the Collective Bargaining Agreement in the form presented to the Town Board and authorizes the Town Supervisor to execute the final Collective Bargaining Agreement between the Town of Stony Point and the CSEA Local 1000 AFSCME effective January 1, 2025 through December 31, 2027 in a final form approved by the Town's legal counsel.
- Section 3. The Town Supervisor Clerk and any other Town officials and/or employees, as directed by the Supervisor, are authorized to take any and all necessary actions to carry out the provisions of this Resolution.
- <u>Section 4</u>. This Resolution shall be effective immediately.
